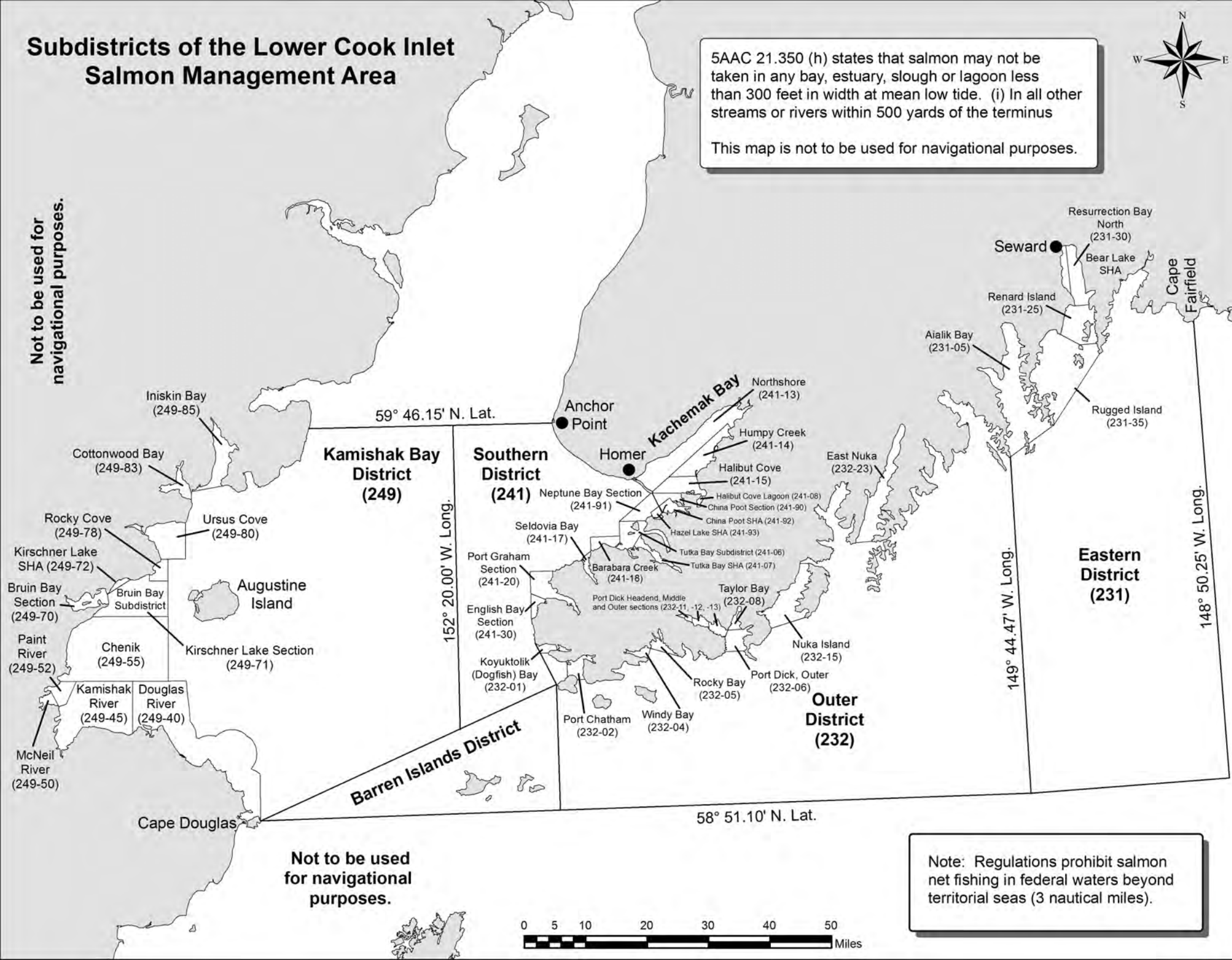

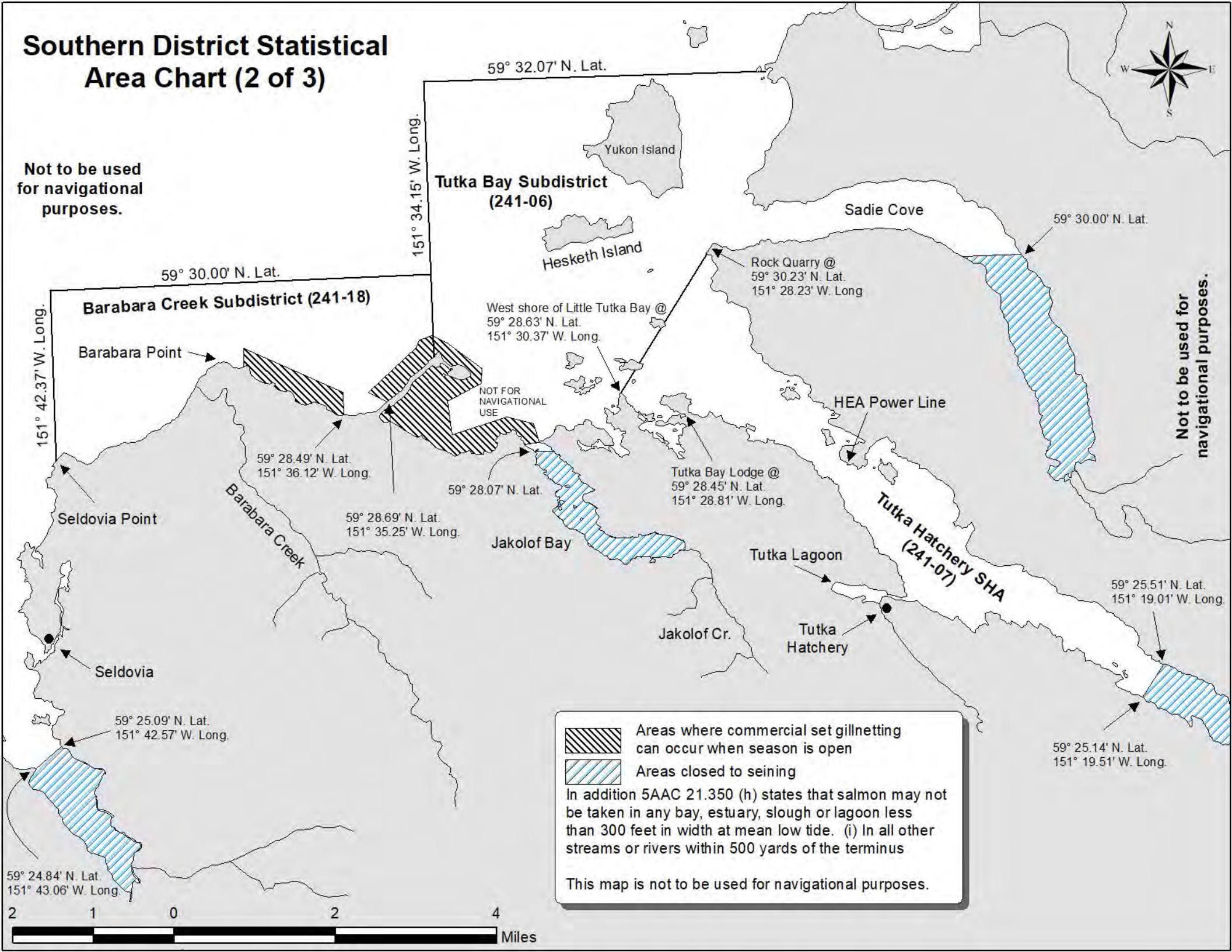
Southern District Statistical Area Chart (1 of 3)

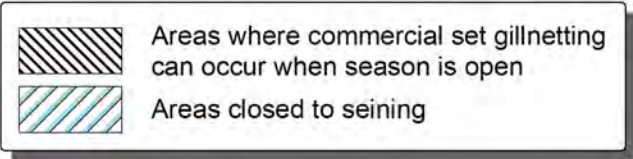

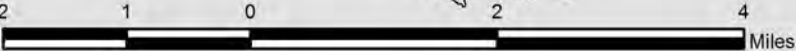

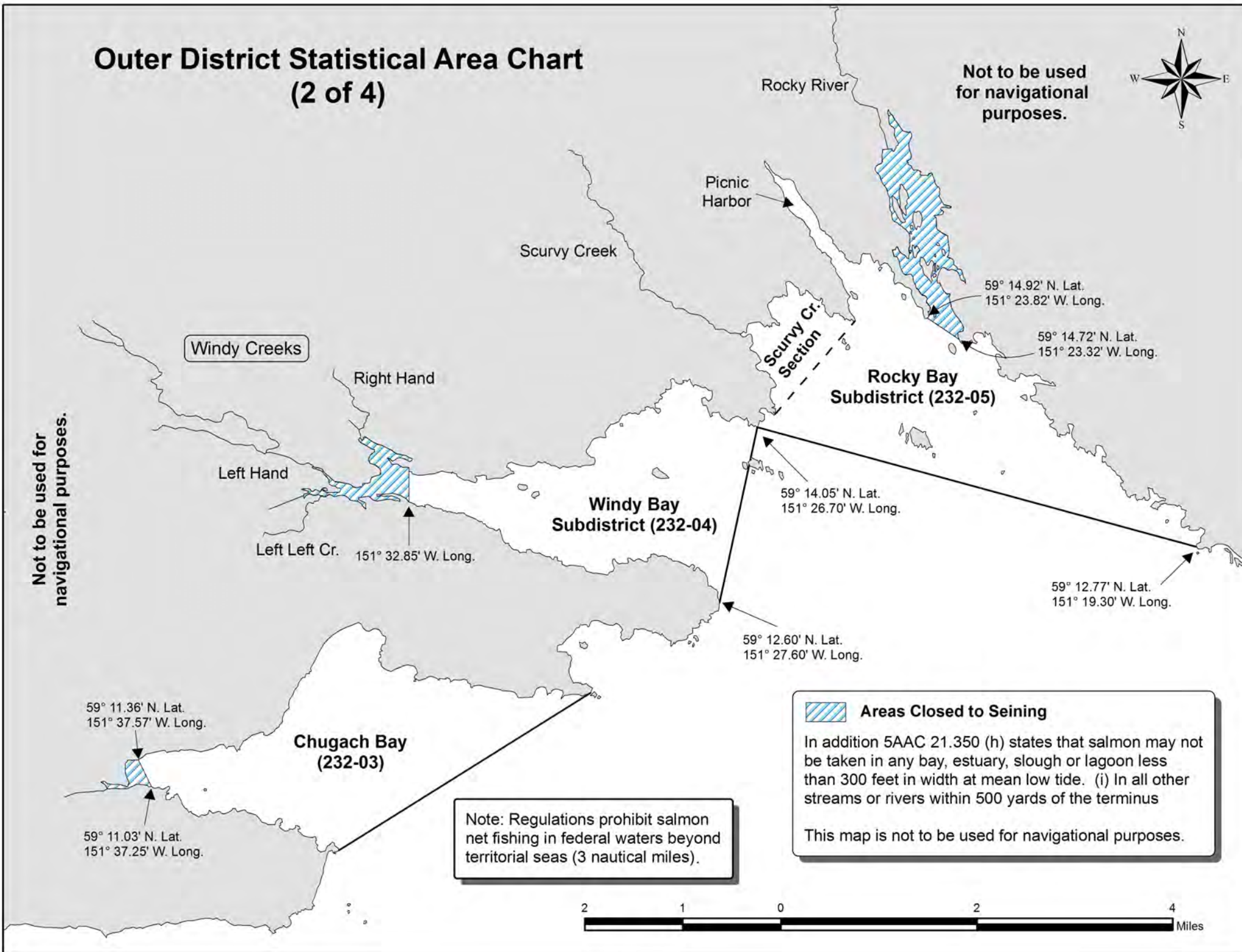

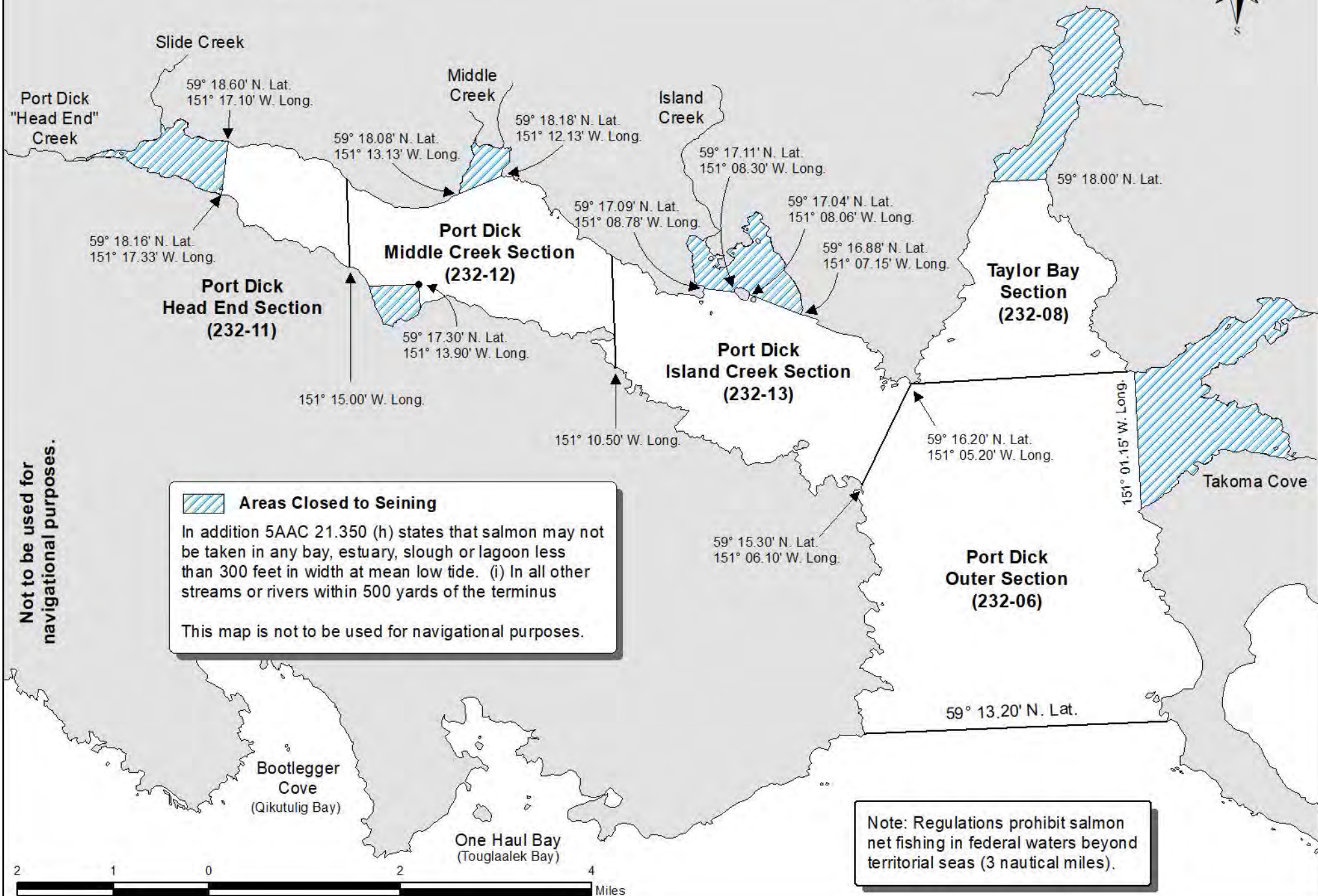

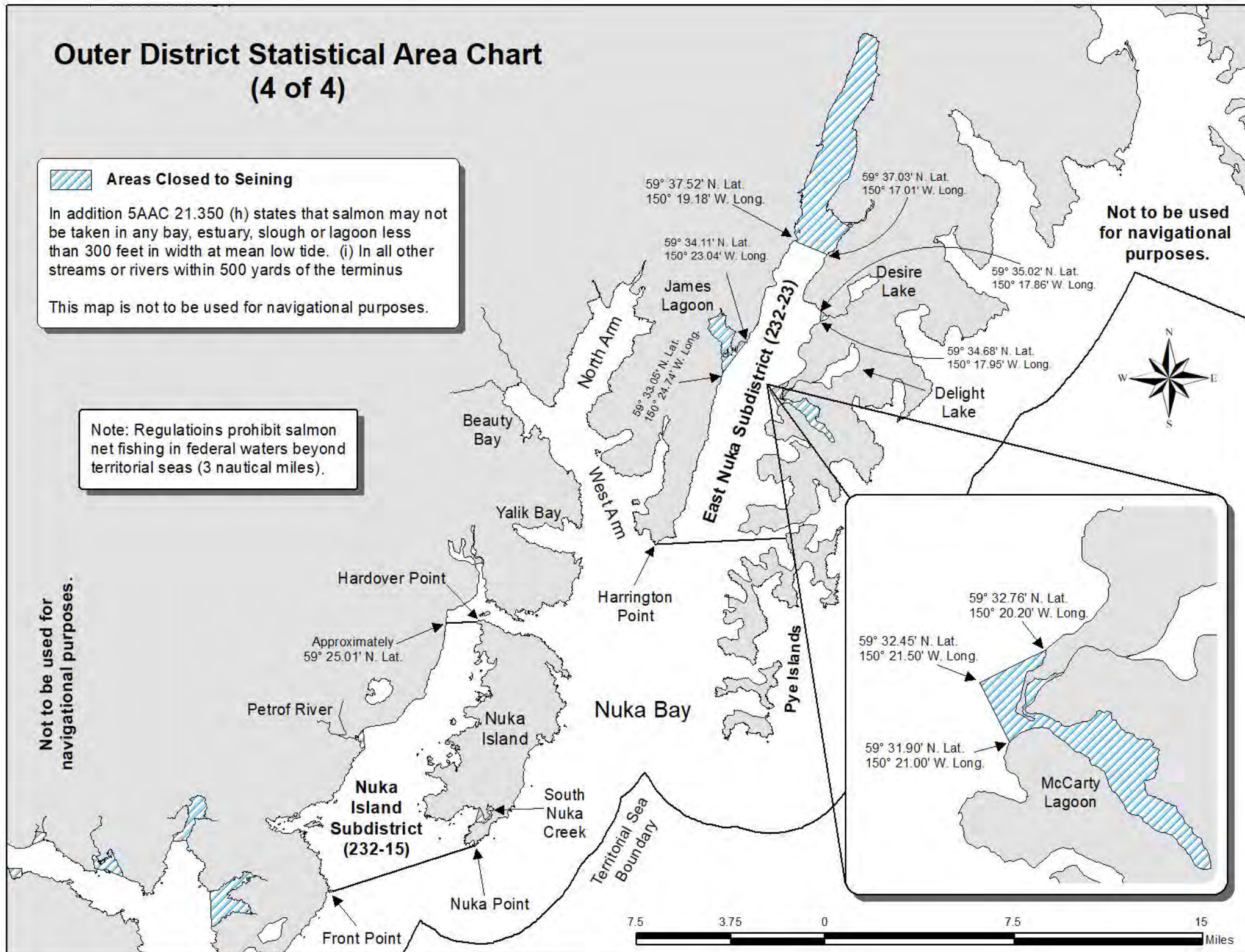

Eastern District Statistical Area Chart (1 of 1)

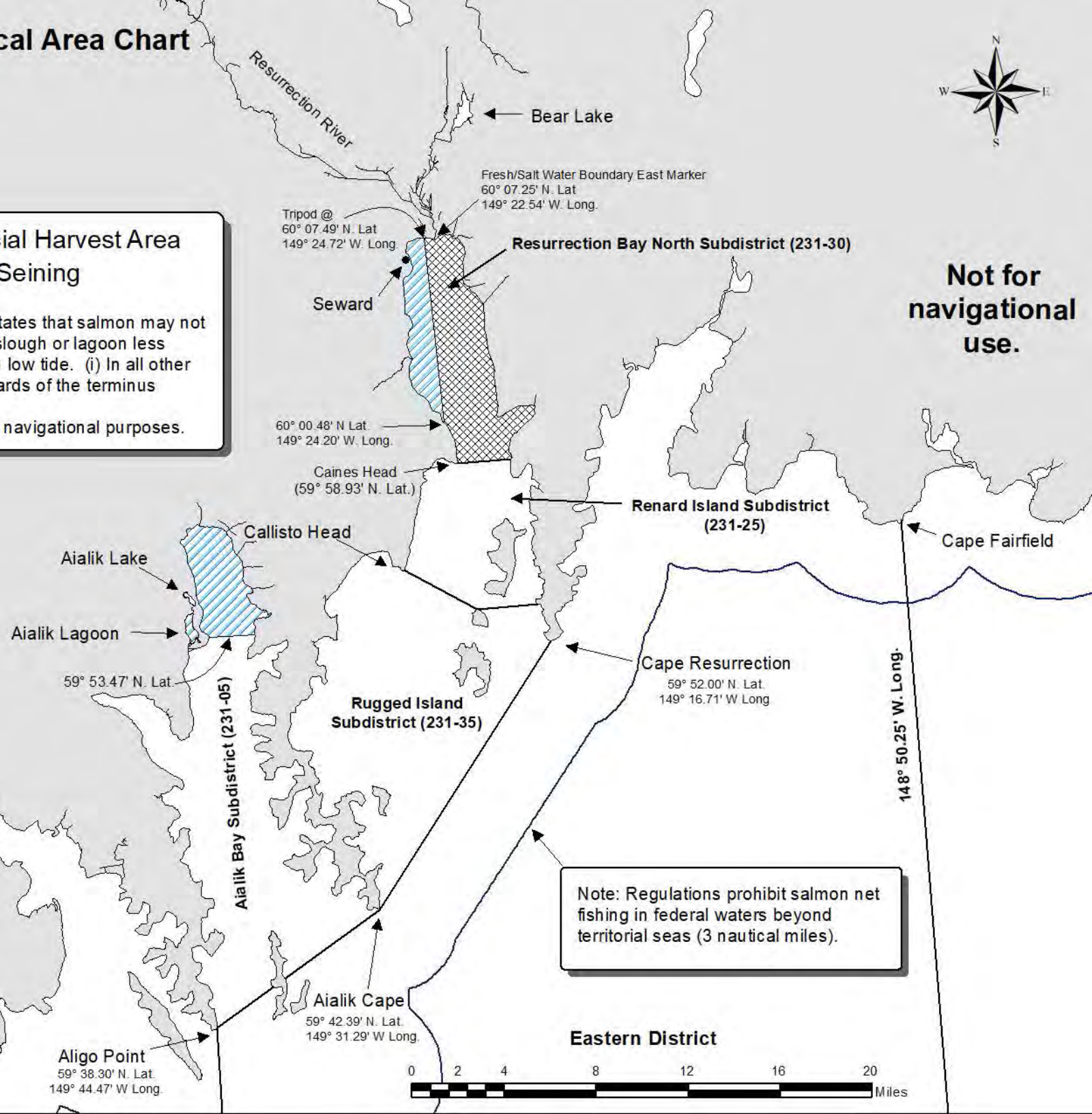

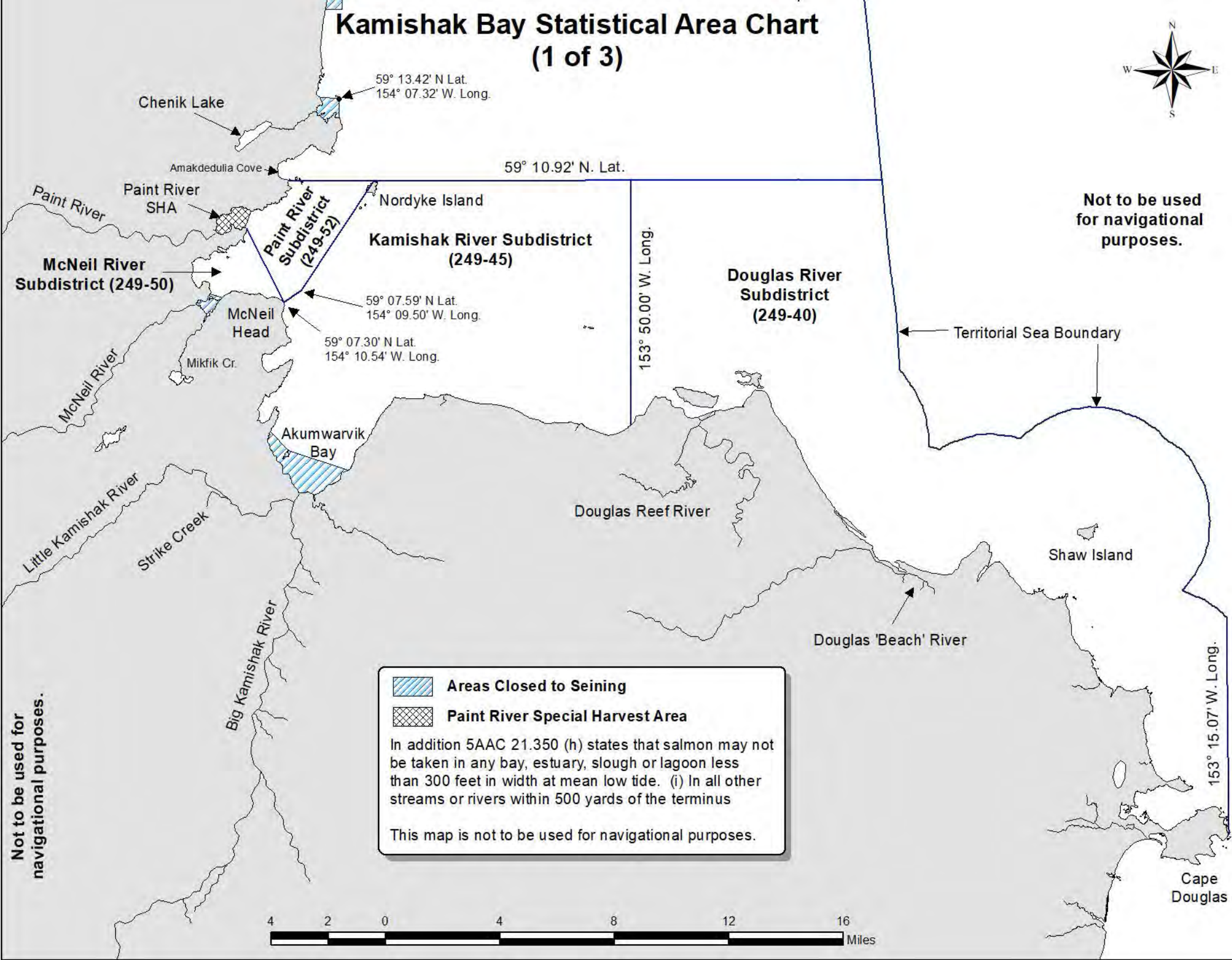

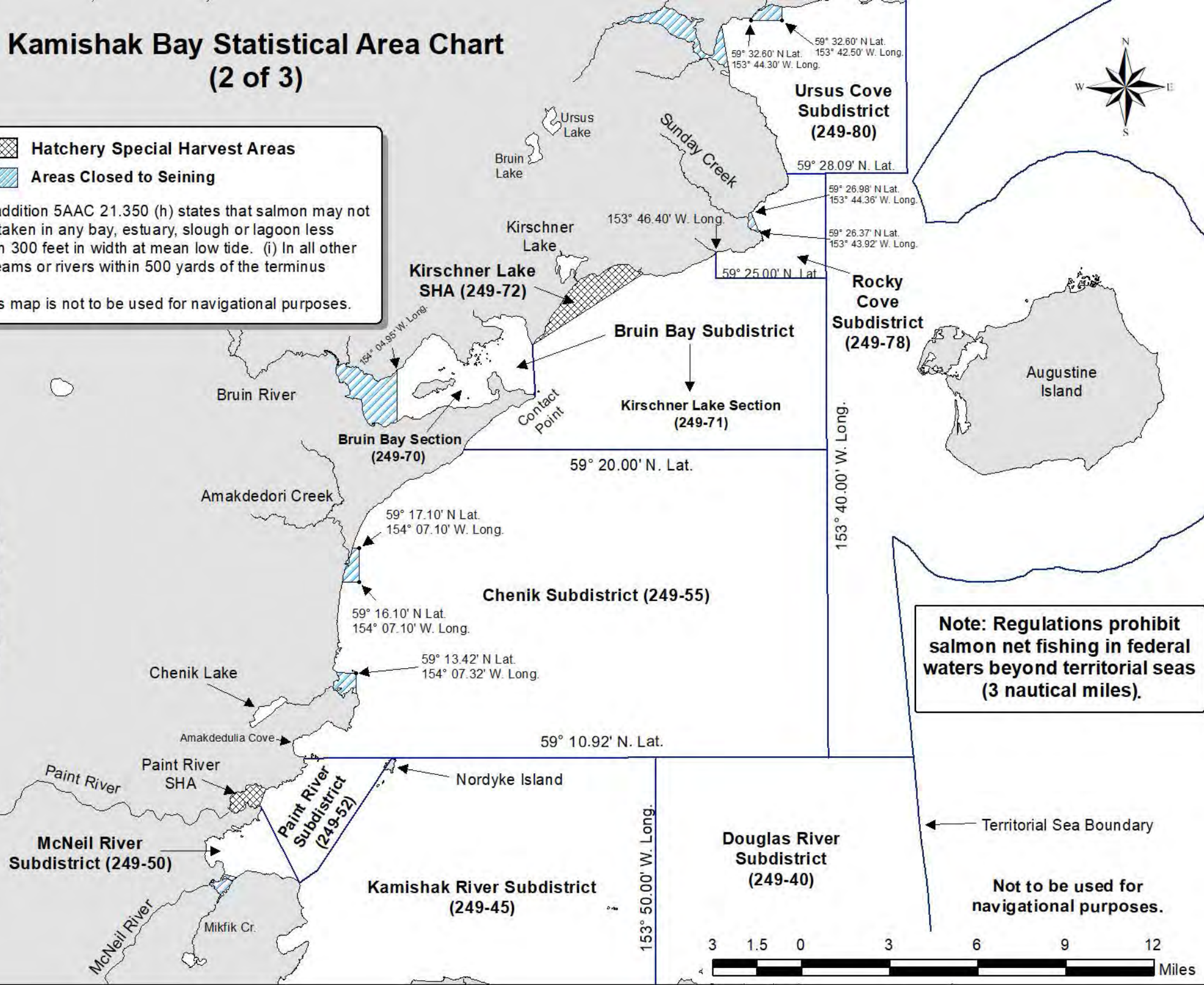
Kamishak Bay Statistical Area Chart (2 of 3)

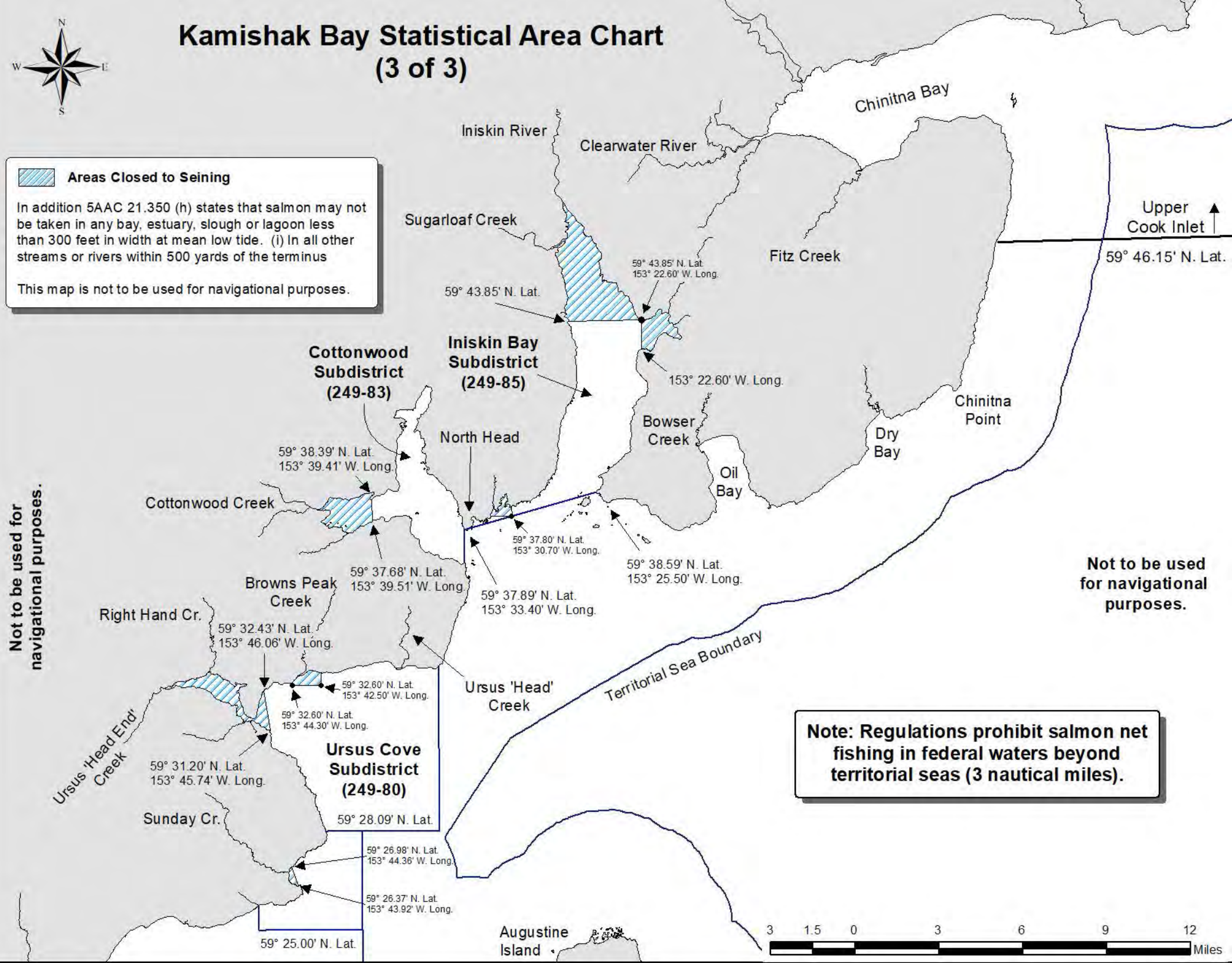

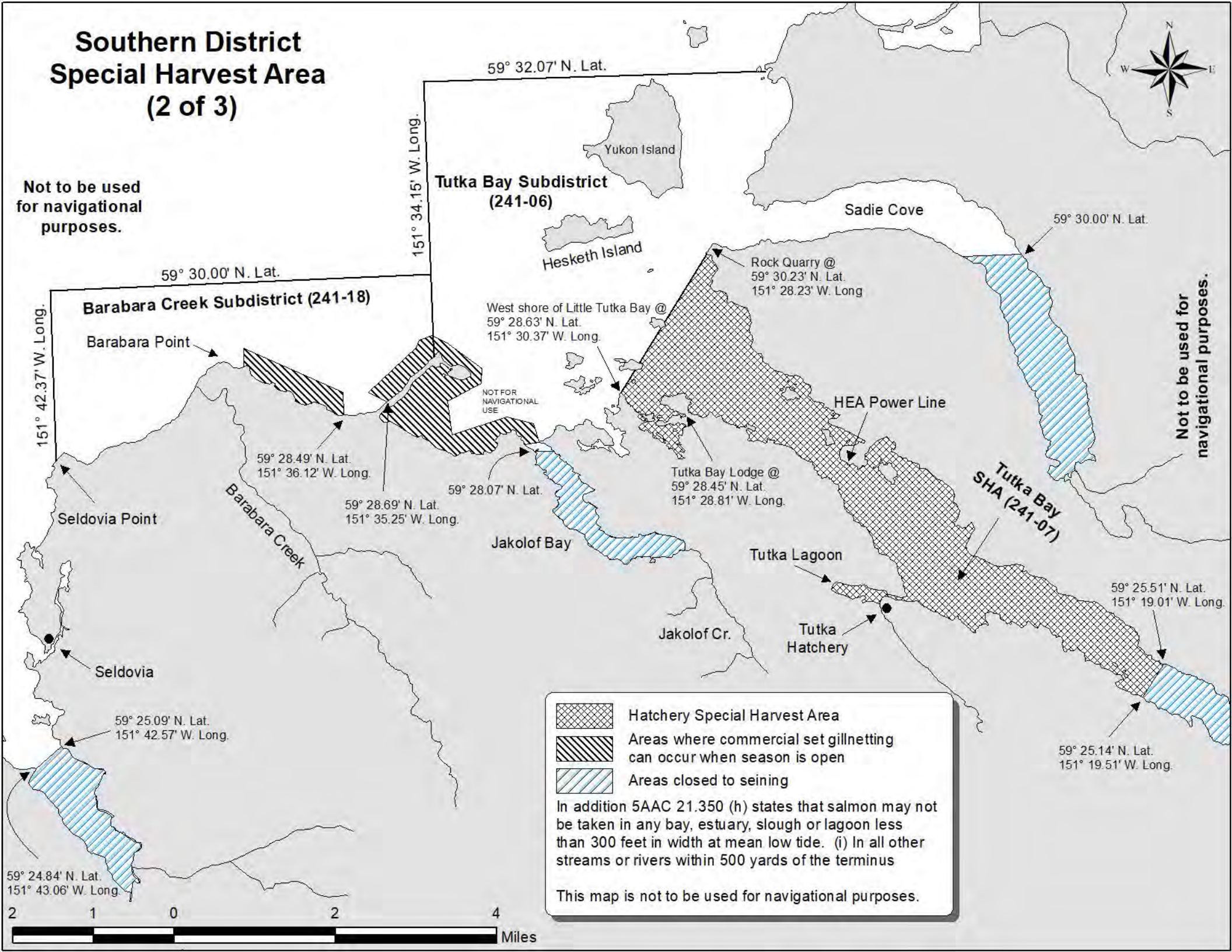

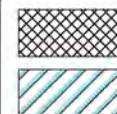
